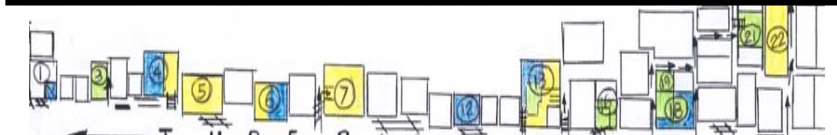
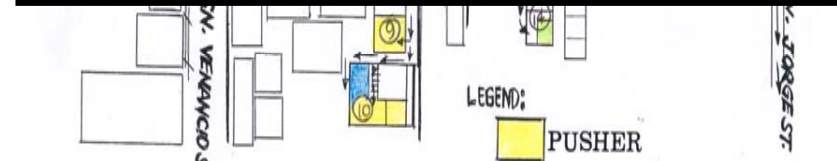

SAN NICOLAS STREET



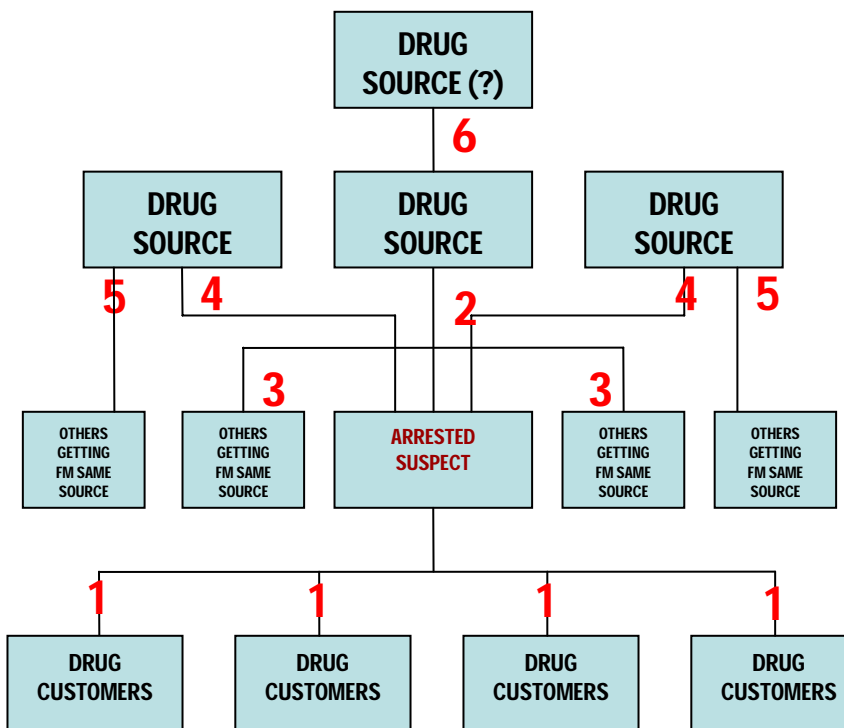
