**SUBJECT: APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN THE DANGEROUS DRUGS BOARD AND THE NATIONAL DAIRY AUTHORITY FOR THE PROVISION OF SUPPORT RELATIVE TO THE IMPLEMENTATION OF NUTRITION MANAGEMENT GUIDELINES IN DRUG ABUSE TREATMENT AND REHABILITATION CENTERS**

**WHEREAS**, the Board is the policy-making and strategy-formulating body in the planning and formulation of policies and programs on drug prevention and control which shall develop and adopt a comprehensive, integrated, unified and balanced national drug abuse prevention and control strategy;

**WHEREAS**, the Board is mandated by Republic Act No. 9165 or the Comprehensive Dangerous Drugs Act of 2002 to extend assistance in the maintenance and operations of Drug Abuse Treatment and Rehabilitation Centers in the country;

**WHEREAS**, the Board, with the technical assistance of the Department of Science and Technology–Food and Nutrition Research Institute (DOST-FNRI), introduced dietary manuals designed to provide nutrition management guidelines on the adoption of a balanced and nutritious diet for persons who use drugs who are currently admitted in drug abuse treatment and rehabilitation centers;

**WHEREAS**, a study conducted by DOST-FNRI has shown strong evidence that diet and nutrition management is necessary to a balanced treatment and rehabilitation plan for persons who use drugs;

**WHEREAS**, the National Dairy Authority (NDA), an attached agency of the Department of Agriculture, markets local milk and milk products sourced from farmers and promotes the dairy industry as a model for asset creation, job generation, and increased income;

**WHEREAS**, the NDA is willing to partner with the Board for the implementation of nutrition management guidelines through the provision of financial support which may be utilized by drug abuse treatment and rehabilitation centers.

**WHEREFORE**, be it **RESOLVED**, as it is hereby **RESOLVED**, to approve the Memorandum of Agreement between the Dangerous Drugs Board and the National Dairy Authority for the provision of support relative to the implementation of nutrition management guidelines in Drug Abuse Treatment and Rehabilitation Centers in the amount of Php 2,000,000.00.
