**BOARD RESOLUTION NO. 16  
Series of 2021**

**SUBJECT: APPROVING THE PROVISION OF FINANCIAL ASSISTANCE FROM THE SPECIAL ACCOUNT IN THE GENERAL FUND OF THE BOARD TO THE SECOND BATCH OF GOVERNMENT TREATMENT AND REHABILITATION CENTERS AND COMMUNITY-BASED TREATMENT AND REHABILITATION FACILITIES FOR CY 2021**

**WHEREAS**, Section 75 of Republic Act No. 9165 or the Comprehensive Dangerous Drugs Act of 2002 provides, among others, that the Dangerous Drugs Board shall support the establishment of government-operated regional treatment and rehabilitation centers and shall give priority funding for the increase of subsidy to existing government drug rehabilitation centers;

**WHEREAS**, Section 87 of the Implementing Rules and Regulations of the same law provides, among others, for the creation of a Special Account in the General Fund (SAGF) in favor of the Board;

**WHEREAS**, the aforesaid provision also provides funding assistance to drug treatment and rehabilitation centers owned and operated by the National Government and its political subdivisions, including establishment and maintenance of new drug abuse treatment and rehabilitation centers in the country as well as the operation and maintenance of existing ones;

**WHEREAS**, to complement the ongoing campaign against illegal drugs of President Rodrigo Roa Duterte, the Board issued Regulation No. 4, Series of 2016 and Regulation No. 7, Series of 2019 calling for the implementation of community-based treatment and rehabilitation programs in local government units in order to introduce appropriate interventions to individuals who have low to mild substance use disorder;

**WHEREAS**, the Treatment, Rehabilitation and Reintegration Committee, with the Department of Health as Chairperson and pursuant to the Internal Rules of the Board, evaluated the requests for assistance and recommended the approval of release of financial assistance from the SAGF for the benefit of selected government in-patient and community-based treatment and rehabilitation centers.

**WHEREFORE**, be it **RESOLVED**, as it is hereby **RESOLVED**, to approve the recommendation of the Treatment, Rehabilitation and Reintegration Committee and authorize the provision of financial assistance to government treatment and rehabilitation centers and community-based treatment and rehabilitation facilities listed in Annex "A" of this Resolution.
