**BOARD RESOLUTION NO. 4
Series of 2021**

SUBJECT: APPROVING THE PROVISION OF FINANCIAL ASSISTANCE FROM THE GENERAL FUND OF THE BOARD TO THE FIRST BATCH OF LGU-OWNED AND OPERATED TREATMENT AND REHABILITATION CENTERS AND COMMUNITY-BASED TREATMENT AND REHABILITATION FACILITIES FOR CY 2021

WHEREAS, Section 75 of Republic Act No. 9165 or the Comprehensive Dangerous Drugs Act of 2002 provides that the Board shall support the establishment of government-operated regional treatment and rehabilitation centers and shall give priority funding for the increase of subsidy to existing government drug rehabilitation centers;

WHEREAS, to complement the ongoing campaign against illegal drugs of President Rodrigo Roa Duterte, the Board issued Regulation No. 4, Series of 2016 and Regulation No. 7, Series of 2019 calling for the implementation of community-based treatment and rehabilitation programs in local government units in order to introduce appropriate interventions to individuals who have low to mild substance use disorder;

WHEREAS, the Treatment, Rehabilitation and Reintegration Committee (TRRC) of the Board, with the Department of Health as Chairperson and pursuant to the Internal Rules of the Board, shall deal with requests for assistance concerning the establishment, putting up, construction, repair and maintenance of treatment and rehabilitation facilities in the country;

WHEREAS, since the TRRC has not yet been formally constituted as of the present time given the ongoing vetting process on its composition, the DDB Secretariat had assumed the responsibility to facilitate technical, administrative and logical requirements to ensure timely disbursements of the annual allocation;

WHEREAS, the DDB Secretariat has recommended approval of release of financial assistance from the General Fund for the benefit of selected 1st batch of LGU-owned and operated in-patient and community-based treatment and rehabilitation centers which requested such assistance.

WHEREFORE, be it **RESOLVED**, as it is hereby **RESOLVED**, that the Dangerous Drugs Board approves the recommendation of the DDB Secretariat and authorizes the provision of financial assistance to LGU-owned and operated treatment and rehabilitation centers and community-based treatment and rehabilitation facilities listed in Annex "A" of this Resolution.
