**BOARD RESOLUTION NO. 9  
Series of 2021**

**SUBJECT: APPROVING THE REQUEST OF THE DEPARTMENT OF HEALTH-TREATMENT AND REHABILITATION CENTER CEBU CITY TO UTILIZE ITS SAVINGS FROM PREVIOUS FUNDING SUPPORT PROVIDED BY THE DANGEROUS DRUGS BOARD FOR OTHER CAPITAL OUTLAY PROJECTS**

**WHEREAS**, Section 75 of Republic Act No. 9165 or the Comprehensive Dangerous Drugs Act of 2002, provides, among others, that the Board shall support the establishment of government-operated regional treatment and rehabilitation centers and shall give priority funding for the increase of subsidy to existing government drug rehabilitation centers;

**WHEREAS**, Section 87 of the Implementing Rules and Regulations of the same law provides for the creation of a Special Account in the General Fund (SAGF) in favor of the Board;

**WHEREAS**, the aforesaid provision also provides funding for assistance to drug treatment and rehabilitation centers owned and operated by the National Government and its political subdivisions, including the establishment and maintenance of new drug treatment and rehabilitation centers in the country as well as the operation and maintenance of existing ones;

**WHEREAS**, to complement the ongoing campaign against illegal drugs of President Rodrigo Roa Duterte, the Board issued Regulation No. 4, Series of 2016 calling for the implementation of community-based treatment and rehabilitation programs in local government units in order to introduce appropriate interventions to individuals who have low to mild substance use disorder;

**WHEREAS**, the Board approved the request of the Treatment and Rehabilitation Center of Cebu City for funding support amounting to Php 19,500,000.00 for the improvement of various infrastructure needs;

**WHEREAS**, in a recently submitted budget utilization report, the said facility declared that the full implementation of the project has been reached, with a declared savings amounting to Php 1,181,249.88;

**WHEREAS**, since it has been the policy of the Board to request implementing agencies to return non-moving, unutilized and savings from the funds downloaded after the completion of the project, the said Center sought the approval of the Board to utilize the remaining balance from the previously downloaded support in the amount of Php 1,181,249.88 for other emerging capital outlay projects, such as renovation for the Bread

and Pastry Room, Renovation of its Clinical Laboratory, and construction of a Storage Room.

**WHEREFORE**, be it **RESOLVED**, as it is hereby **RESOLVED**, to approve the request of the Department of Health-Treatment and Rehabilitation Center Cebu City to utilize its savings in the amount of P 1,181,249.88 from previous funding support to other capital outlay projects.
